



Activity, Field Trip & Photo/Artwork Release Permission/ Permission to Treat

I give my full permission for _____ to attend and participate in supervised and planned activities, movies, video games and field trips at **BELLEVIEW CHRISTIAN SCHOOL**. Activities off campus may necessitate students being transported in church/school-owned or private vehicles or short walks, including walking to Bishop Park at 82nd & Hooker Street. I further give full and complete consent for the staff / teachers to take such action (even admittance to a hospital) as they deem necessary in case my child needs medical attention resulting from illness or accident whether on or off campus. I understand I will be notified as soon as possible if such an incident should occur. I further absolve **BELLEVIEW CHRISTIAN SCHOOL** and the staff/teachers from liability due to any accident or illness. I also grant permission for my child to use sunscreen at school or at an off-campus field trip.

In consideration of granting my permission, I am entering into this release agreement, which extends to the following: Pillar of Fire, a Colorado Not-For-Profit Corporation, Bellevue Christian School, as well as any trustees, directors, board members, agents, employees, volunteers, contractors, or any other representatives.

I understand that my child's participation could subject my child to numerous dangers or risks of personal injury. These risks and dangers have been considered and relying on my own judgment, I have voluntarily chosen to allow my child to participate and I will assume all such dangers and risks. I certify that my child is in suitable health and capacity, which allows the child's participation.

I knowingly and voluntarily release, waive and further agree to hold harmless any and all of the above named parties. I further agree to reimburse any expenses incurred that result from any injury, accident or damage in connection with my child's involvement in any school activity.

INSURANCE: I understand that the Pillar of Fire and/or Bellevue Christian School does not carry insurance sufficient to cover the cost of injuries that may occur during a school activity. I understand that my own insurance is required for such occurrences and that lack of insurance or sufficient insurance will require out-of-pocket expense on my part. I request that the above named student be allowed to participate in the activity and specifically consent to his/her participation. This release agreement shall be construed to be as comprehensive as is allowed by law.

PHOTO/ARTWORK RELEASE: Throughout the year, there are occasions when BCS may want to use their work (artwork, poetry, etc) and take pictures/videos of your student participating in activities related to the school. We may use, these items in various publications including the school website, local newspapers, or advertisements.
